- Each invoice is due and payable within 10 days from the invoice date.
- If equipment is rented for more than 4 weeks, periodic unsigned invoices will be issued for rental charges due. All such invoices are due and payable within 10 days of the invoice date.
- At the discretion of All American Rentals, any account with a delinquent balance may be placed on a cash basis at any time, and the equipment picked up without notice.
- All American Rentals files preliminary lien notices and mechanics' liens whenever necessary or required by law. This is a company policy, and is not a reflection on your credit standing.
- Customer agrees to pay all reasonable attorney fees, collections costs, and court costs incurred by All American Rentals in enforcing these items and conditions.
- Customer authorizes All American Rentals to obtain credit reports, trade reports, and bank references for the purpose of determining the extension or continuation of credit to a customer.
